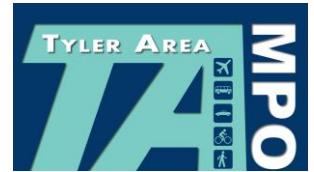
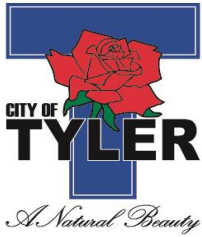

The public is invited to attend an open house to be held by the Tyler Area Metropolitan Planning Organization (MPO) in an effort to amend the 2017 – 2020 Transportation Improvement Program (TIP). The purpose of the TIP is to list the transportation improvements that are planned to be implemented within the 2017 through 2020 fiscal years. The amendment involves the addition of Transportation Alternatives Set-Aside (TA Set-Aside) grant awarded to the City of Tyler for a 56-mile bike lane striping project. This meeting kicks off a 10-day public comment period to be held from January 9, 2018 – January 19, 2018 for the revision to the TIP, which will be considered for adoption at the MPO Policy Committee Meeting on January 25, 2018 at 2:00 p.m. This public notice of public involvement activities and time established for public review and comments on the TIP development process will satisfy the Federal Transit Administration’s (FTA) program of the project requirements.

There is the possibility that a quorum of the Tyler Area Metropolitan Planning Organization Transportation Policy Committee will be present at the *Tyler Area Metropolitan Planning Organization 2017 – 2020 Transportation Improvement Program Open House on Tuesday, January 9, 2018 between 5:30 p.m. and 6:30 p.m.*, located at the *Tyler Development Center, 423 West Ferguson Street, Tyler, Texas.*
