

ORDINANCE NO. 0-2008-106

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING CHAPTER 1, "GENERAL PROVISIONS", ARTICLE III., "BOARDS", OF THE CODE OF ORDINANCES OF THE CITY OF TYLER, TEXAS, REMOVING REFERENCES TO BOARDS NO LONGER IN EXISTENCE; LOWERING THE NUMBER OF MEMBERS OF THE DISABILITY ISSUES REVIEW BOARD; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, certain sections of Chapter 1, "General Provisions", Article III., "Boards" are outdated and need to be either amended or deleted; and

WHEREAS, the Shackleford Creek Annexation Board was created in 1998 to assist citizen and City communication during the annexation transition of that property and was to have a term of two years only;

WHEREAS, the Lake Tyler Advisory Board was created in 2004 to act in an advisory capacity and to provide a vehicle for citizen communication with and assistance to the City departments and the City Council to facilitate recreational, residential, and mineral production uses of Lake Tyler and was to have a term of three years only;

WHEREAS, the Disability Issues Review Board would be able to function more efficiently with a smaller number of members; and

WHEREAS, the Convention & Visitors Bureau Board was established to assist the City and Chamber of Commerce in attracting more visitors and conventioners to Tyler; to provide oversight and direction to the Chamber of Commerce and City of Tyler in those activities related to tourism and conventions; and to make recommendations to Chamber of Commerce and City regarding annual budgets, advertising marketing plans, and services provided by the Chamber of Commerce; and

WHEREAS, the need for the Convention & Visitors Bureau Board has now been replaced by a new contract with the Chamber of Commerce;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That City Code Chapter 1, "General Provisions", Article III., "Boards" is hereby amended by deleting Sections 1-24 and 1-25 in their entirety and reserving the sections.

Sec. 1-24. Reserved.

PART 2: That City Code Chapter 1, "General Provisions", Article IX., "Disability Issues Review Board," is hereby amended by amending City Code Section 1-90.a to read as follows:

ARTICLE IX. DISABILITY ISSUES REVIEW BOARD


Sec. 1-90. Creation; appointments and officers.

a. There is hereby established the Disability Issues Review Board. The Board shall be composed of seven (7) interested Tyler citizens appointed by the City Council and serving terms as set forth in Section 1-20 of this Code. Appointees should be interested in some phase of service to persons who are physically, emotionally or mentally disabled. (Ord. No. 0-2008-106, 8/27/08)

PART 3: That City Code Chapter 1, "General Provisions", Article X., "Convention & Visitors Bureau Board," is hereby deleted in its entirety.

PART 4: That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.
