

ORDINANCE NO. O-2008-67

AN ORDINANCE DECLARING THE RESULTS OF AN ELECTION HELD IN THE CITY OF TYLER, TEXAS, ON THE 10th DAY OF MAY, 2008, FOR THE ELECTION OF MAYOR, CITY COUNCILMEMBER FOR THE WEST DISTRICT, NO.2, CITY COUNCILMEMBER FOR THE NORTHEAST DISTRICT, NO. 4, AND CITY COUNCILMEMBER FOR THE SOUTH DISTRICT, NO. 6.

WHEREAS, on the 21st day of May, 2008, the City Council of the City of Tyler, Texas, at a meeting specially called for the purpose, canvassed the returns of the City Council Election held on the 10th day of May, 2008, in the City of Tyler, for the election of Mayor, City Councilmember for the West District, No. 2, City Councilmember for the Northeast District, No. 4, and City Councilmember for the South District, No. 6, for the City of Tyler, Texas, and it appearing as a result of such canvass that the following named persons received the following number of votes for Mayor, City Councilmember West District No. 2, Northeast District No. 4, and South District No. 6:

Mayor At Large

Barbara Bass 4,103 Votes Laura Corbett 2,567 Votes Keith Pyron 65 Votes

West District No.2, For City Councilmember

Donald Sanders 210 Votes

Northeast District No. 4, For City Councilmember

Chris Simons 465 Votes

South District No. 6, For City Councilmember

Larry Meckley 298 Votes Charles Alworth 1,464 Votes

And it further appearing from such canvass that **Barbara Bass** received the highest number of votes cast for Mayor, At Large; **Donald Sanders** received the highest number of votes for City Councilmember, West District, No. 2; **Chris Simons** received the highest number of votes for City Councilmember, Northeast District, No. 4; and **Charles Alworth** received the highest number of votes for City Councilmember, South District, No. 6; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That Barbara Bass is hereby declared the duly elected Mayor, to serve for a two-year term of office.

PART 2: That Donald Sanders is hereby declared the duly elected City Councilmember for the West District, No. 2, to serve for a two-year term of office.

PART 3: That Chris Simons is hereby declared the duly elected City Councilmember for the Northeast District, No. 4, to serve for a two-year term of office.

PART 4: That Charles Alworth is hereby declared the duly elected City Councilmember for the South District, No. 6, to serve for a two-year term of office.

PART 5: That this ordinance shall take effect immediately upon its adoption.
