

**ORDINANCE NO. O-2008-83**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, ESTABLISHING A TEMPORARY CONSTRUCTION SPEED LIMIT OF 35 M.P.H., WHEN SO POSTED OR INDICATED, FOR TRAFFIC TRAVELING NORTH AND SOUTH ON NEW COPELAND RD. FROM REICK RD, SOUTH TO PALUXY DR.; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, it is the intent of the City Council to protect the public health, safety, and welfare; and

**WHEREAS**, Tyler City Code Section 17-63 establishes certain speed limits with the City limits; and

**WHEREAS**, The City of Tyler is in the process of constructing Grande Blvd. from Sutherland Dr. east to Troup Hwy.; and

**WHEREAS**, the project will include the reconstruction of New Copeland Rd. from Rieck Rd. south to Paluxy Dr; and

**WHEREAS**, the Traffic Engineering Department has determined that a construction speed zone of 35 m.p.h. will be required for the project while under construction;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**


**PART 1:** That any and all ordinances or parts of ordinances relating to speed zones on Grande Blvd. within the project limits in the City of Tyler are hereby temporarily revised as follows:

- The limits for New Copeland Rd. traffic traveling both North and South for which a maximum speed of 35 miles per hour applies, when said speed is so posted and/or indicated, is hereby ordained and shall extend from Rieck Rd., South to Paluxy Dr. until the completion of the City of Tyler construction project, Smith County.

**PART 2:** That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

**PART 3.** That any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine as provided in Section 1-4 of the Tyler Code. Each day such violation shall continue, or be permitted to continue, shall be deemed a separate offense. Since this ordinance has a penalty for violation, it shall become effective upon its publication in the newspaper as provided by Section 85 of the Charter of the City of Tyler, Texas, which date is expected to be Monday, June 30, 2008.
