

ORDINANCE NO. O-2009-37

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING THE BUDGET FOR FISCAL YEAR 2008-2009 AUTHORIZING THE APPROPRIATION OF FUNDS FROM THE \$100,000 BASEBALL TOMORROW FUND GRANT FOR CONSTRUCTION OF A SOFTBALL FIELD AT FAULKNER PARK ORIGINALLY APPROVED IN THE 2007-2008 BUDGET WITH THESE FUNDS SPECIFICALLY USED FOR FIELD LIGHTING PURCHASED SOLELY THROUGH MUSCO LIGHTING; AUTHORIZING THE APPROPRIATION OF FUNDS; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, during fiscal year 2007-2008, City Council approved changes to the Faulkner Park Master Plan for the conversion of one baseball field into three girls' fast pitch softball fields; and

WHEREAS, a conditional grant of \$100,000 from The Baseball Tomorrow Fund was accepted by City Council at the February 25, 2009 meeting (Item M-6) for construction of a softball field at Faulkner Park, but the budget was not amended to appropriate these funds in Revenue and Expense accounts; and

WHEREAS, this budget amendment will provide funding for field lighting for girls fast pitch field #3 at Faulkner Park during the current fiscal year;

WHEREAS, a condition of the grant states that funds must be used to purchase field lighting solely from Musco Lighting which can be done using the BuyBoard; and

WHEREAS, it was necessary to move forward with the purchase of this lighting as an emergency purchase from the BuyBoard in order to have the field ready by the beginning of League play and the City Council is requested to ratify that purchase at the same time as the adoption of this ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That the following line item accounts as approved in the budget for fiscal year 2008-2009 shall be amended to read as follows:



PART 3: That amendment of the fiscal year 2008-2009 Budget at this time is required in order to provide funding for field lighting for girls fast pitch softball field #3 at Faulkner Park from The Baseball Tomorrow Fund Grant, so that construction can be completed without delay which creates an urgent public necessity to authorize the amendment to the budget herein contained.


PART 4: That this ordinance shall take effect immediately upon approval.

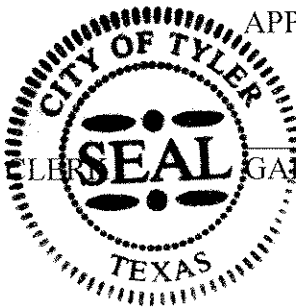
