Please attach as Exhibit D copies of all liability insurance policies required under City Code Section 17-135 or certificates of insurance from an insurance company(ies) authorized to do business in the State of Texas evidencing that such polices are in force or binding to provide such liability insurance prior to the commencement of service.

10. Please attach as Exhibit E a complete and up-to-date financial statement of the applicant, partnership, association or other, every partner or associate, and if such applicant be a corporation, a complete and current balance sheet of such corporation. Any such financial statement shall be kept confidentially except for those City officials or employees involved in reviewing the application. Once the application process is completed, the City shall return the financial statement to the applicant.

11. Please attach a statement from a taxing authority certifying any taxes owed to City on property to be used in connection with permit are current.

12. Have you attached a check in the total amount of the annual fees for the entire term of the permit? If yes, check box. (Annual fee for the permit is \$250.00.
