Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Operation Management-

- o Mission Statement: To provide affordable housing opportunities for low-income households in Smith County in an environment that preserves personal dignity and in a manner that maintains the public trust.
- o Assistance Check is the primary, electronic source and method for voucher holders to utilize when communicating with THA along with transmitting and receiving documents between THA and participating participants and owners.

Substantial Deviation-

- o Policy adjustments related to the following:
 - o "Purpose of Plan" stating assistance Check is the primary, electronic source and method for voucher holders to utilize when communicating with THA along with transmitting and receiving documents during annual re-exams.
 - o "Applying for Admission" with regards to persons owing monies to the agency and paying the agency in full prior to the issuance of a voucher (if/when selected from the waiting list).
 - o Completion of Full Application stating all adult family members are required to attend the interview virtually and/or in person. Forms must be signed and uploaded through Assistance Check and/or mail
 - o Maintaining the Waiting List indicating a specified number of slots (determined by THA when the waiting list is opened) to be placed on the active list.
 - o Subsidy Standards stating the need of the agency to requests updated reasonable accommodation information to verify the continued use/need of an additional bedroom previously requested for medical-related equipment.
 - o Briefing Types and Required Attendance referencing virtually conducted briefings through teleconference or WebEx by Housing Specialists. Materials may also be made available and/or provided online or uploaded through Assistance Check.
 - o Owner Rents, Rent Reasonableness and Payment Standards referencing rent to owners in the Housing Choice Voucher Program and THA's practice to request of participating owners to limit all necessary rental increases to a maximum of five percent or below.
 - o Recertifications/ Annual Activities where Enterprise Income Verification reports are run at the time of annual recertifications to determine and/or discuss any income discrepancies with the client(s). THA may run EIV reports and conduct reviews as necessary based on HUD's expectation of agencies to use EIV/ Income Verification Tool (IVT).
 - o Housing Quality Standards and Inspections stating the use of alternative inspection options such as technology to perform virtual inspections and accepting owner self-certifications that the owner has no reasonable basis to have knowledge that life threatening conditions exist in the unit or units in question.
 - o Moves with Continued Assistance/ Portability stating THA will not issue HAP for any day prior to the participant's move out date; however, if special circumstances arise with the participant and receiving PHA, THA will review on a case by case basis and may choose to issue pro-rated HAP to the new owner which may overlap HAP for the month (which will not be considered duplicate housing subsidy; however, overlapping HAP payments are not allowed if the owner of the new unit and the previous unit is the same).
 - o Violence Against Women Act and the collaboration of THA with local law enforcement to determine the needs of the residents and community, working towards a mutual goal of ensuring and improving the safety of residents. THA has undertaken partnerships with local organizations to enable THA to serve the needs of child and adult victims of domestic violence, dating violence, sexual assault or stalking.
 - o Family Self-Sufficiency final disbursement of the escrow account being processed within 180 days from the date of program completion.
